Minutes of Meeting

- I. **Call Meeting to Order.** The meeting was held at the Nieves M. Flores Memorial Library in Hagatna, Guam, and was called to order by Debra S. Duenas, Chairperson, on January 15, 2015 at 3:36pm.
 1. Roll Call
Present: Ms. Debra Duenas, Chairperson; Mr. Krishnan Seerengan, Vice-Chair; Denise Reyes, Board member; Kyle Mandapat, Treasurer; Sandra Stanley, Administrative Officer; Frankie Aflague, Program Coordinator; Jasmine Stole, Reporter from Marianas Variety
Absent: Joseph Artero Cameron, President of DCA; Teresita LG Kennimer, Library Technician Supervisor.

- II. **Approval of Minutes.** Chairperson advises the board that the minutes was emailed to all members for their review on Tuesday, March 3, 2015. Motion was made by Denise to accept minutes with second motion made by Kyle; all in favor with unanimous acceptance of board minutes. Chairperson approves the minutes with June Aflague countersigning.

- III. **Reports.** Ms. Sandra Stanley, Administrative Officer distributed to all board members and reported as follows:
 - Per Mr. Cameron, President – DCA, our board chairperson is not allowed to vote because she is the Chair, and therefore, board does not meet quorum. Board Member Kyle Mandapat brought this issue up after Mr. Cameron stated the same during the Educational Program held at DCA Conference room.
 - Update provided to the board on the status of the split ac units. As of January 15th, work began on the installation. Two vendors were awarded the projects at a total cost of \$103,190.00. There are a total of (16) split ac units that are being installed. Vendors are Guam Modern Office & JRN.
 - Department of Interior (DOI) Project.
Contractor is still working on obtaining the necessary licenses in order to proceed.
 - Dededo Branch Library. An invitation to bid was published on Dec 22nd and the 24th in the Marianas Variety. Total appropriation for this project is \$64,118.00.
 - Recruitment for Building custodian. Recruitment is in process. The department currently has (3) custodians.
 - A Library Technician I position was vacated in FY2013 but was not approved by DOA HR to fill due to the reorganization advisory in place.
 - Public Law 31-118...Relative to Arts in building and facilities is a mandate that GPLS needs to comply with. The total cost of constructing two new buildings is \$991,466.72, in which 1% is mandated for Arts in Building which comes out to \$9,914.67. A meeting

will be scheduled with Jackie Balbas with CAHA and GPLS Board has indicated that they would like to be included in the meeting. Administrative cost of (2%) will be transferred to CAHA of \$198.29.

Board members upset why are they being told this just now after already having several board meetings since October of 2014.

PROGRAMS: Frankie Aflague, Program Coordinator advises the board of upcoming events for GPLS, Dr. Seuss & Chamorro Month. GPLS has not been any outreach programs the last several months due to shortage of staff.

IV. Old Business.

- 1. Friends of the Library (non-profit).** This is a working progress with Kyle.
- 2. Volunteer Policies.** Ms. Denise dropped off CWEP (Community Work Experience Program) applications. Sandy to review and begin communication with Department of Public Health. Individuals receiving public assistance are enrolled in this program with DPH. Due to staff shortage, the library can avail of this assistance with DPH.
- 3. Job Description.** New salary for the Director, according to the hay study is \$70,000.00. Board all agrees that it's a bigger improvement as compared to the previous of \$55,000.00.

Chairperson says that each branch library should have a librarian. At the least, the main library should have one.

- 4. Board Manual.** Ms. Debra Duenas is still reviewing and working on the board manual.

V. New Business.

1. Status of Donation related to Sale of Books by Local Authors

Kyle sold first run of books and has another run planned. He asked the board if it would be a good idea to wait for the donation of the sales when the "Friends of the Library" is all set up. All agree that it would be a great idea.

VI. Open Discussion.


Jasmin Stole, reporter from Marianas Variety was present during the board meeting. She was basically there to inquire on the many projects taking place with GPLS, the ac units' installation, re-opening of the Hagatna branch library, DOI project and most recently the Dededo library renovation. She also inquires as to why GPLS does not have a librarian. Board explains that it's been years since funding has been available for the position.

Sandy says that it's all GPLS employees that are the ones running the library without a librarian. However, we do need the funding. She also goes on to say that the last ten years it's been the employees of GPLS writing the grants for the department even without a librarian.

Other Matter(s):

Dededo Branch Library

The Project started this week on Tuesday, March 3, 2015. As of yesterday morning when I visited the library, the removal of floor tiles were about 90% completed.

Recruitment for a Building Custodian

We have one new employee on board as of February 26, 2015 filling the vacant position of building custodian.

Arts in Public Building. Public Law 31-118 ...Relative to Arts in Buildings and Facilities is a mandate that GPLS need to comply to. The total cost of constructing two buildings here in Agana is \$991,466.72 which Project was awarded to S. K. Construction, Inc. & Giant.

The one percent (1%) of \$991,466.72 mandated for Arts in Buildings is: \$9,914.67. A meeting will be scheduled by Jackie Balbas with CAHA and GPLS Chairperson D. Duenas had indicated that she would like to be included in the meeting so that she will share her visions on what she would like to see procured. All board members are also invited to attend. ***Administrative cost of (2%) will be transferred to CAHA – amount is: \$198.29***

Proposed Budget Request – FY 2016

Guam Public Library System budget request for Fiscal Year 2015 as approved by Bureau of Budget & Management Research (BBMR) was submitted to the Guam Legislature on March 3, 2015.

The budget ceiling authorized is \$1,535,478.
