



**AN ACT TO CONFORM THE GUAM WAGE AND
HOUR LAW TO CHANGES IN THE FEDERAL FAIR
LABOR STANDARDS ACT REGULATIONS BY
AMENDING TITLE 22 G.C.A. §3108(b), BY *REPEALING*
THE FIRST FOUR SUBSECTIONS OF RULE ONE OF
E.O. 61-14 AND THEIR CORRESPONDING SECTIONS
IN TITLE 17 G.A.R. §4101, DEEMING TITLE 17 G.A.R.,
DIVISION 1, CHAPTER 4 *AMENDED* TO CONFORM
TO FEDERAL REGULATIONS ON WAGE AND HOUR
ISSUES AND ALSO TO REQUIRE THE DIRECTOR OF
LABOR TO POST SAID LAWS ON THE DOL WEBSITE.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Title 22 G.C.A. §3108(b) is *amended* to read:

3 “(b)(1) Any employee who is employed in a bona fide
4 executive capacity, which is any employee who is compensated on a salary
5 or fee basis at a rate of *not less than* Four Hundred Fifty-five Dollars
6 (\$455.00) per week and whose primary duty is management of the enterprise
7 where the employee is employed or of a recognized department thereof; who
8 customarily and regularly directs the work of two (2) or more other
9 employees; and who has the authority to hire or fire other employees or
10 whose suggestions and recommendations as to hiring, firing, advancement,
11 promotion, or any other change of status of other employees are given
12 particular weight.

13 (2) Any employee who is employed in a bona fide
14 administrative capacity, which is any employee who is compensated on a
15 salary or fee basis at a rate of *not less than* Four Hundred and Fifty-five
16 Dollars (\$455.00) per week and whose primary duty is the performance of
17 office or non-manual work directly related to the management of the general
18 business operations of the employer or the employer’s customers, and whose
19 primary duty includes the exercise of discretion and independent judgment
20 with respect to matters of significance.

21 (3) Any employee who is employed in a bona fide
22 professional capacity, which is any employee who is compensated on a
23 salary or fee basis at a rate of *not less than* Four Hundred Fifty-five Dollars
24 (\$455.00) per week and whose primary duty is the performance of work
25 requiring knowledge of an advanced type in a field of science or learning
26 customarily acquired by a prolonged course of specialized intellectual
27 instruction or requiring invention, imagination, originality or talent in a

1 recognized field of artistic or creative endeavor. It shall also include
2 computer systems analysts, computer programmers, software engineers or
3 other similarly skilled workers in the computer field.

4 (4) Any employee who is employed as an outside
5 salesperson, which is an employee who is employed for the purpose of and
6 who is customarily and regularly engaged away from the employer's place
7 of business in making sales or obtaining orders or contracts for services or
8 the use of facilities for which a consideration will be paid by the client or
9 customer.

10 (5) Any employee with a primary duty of teaching, tutoring,
11 instructing or lecturing in the activity of imparting knowledge and who is
12 employed in this activity as a teacher in an educational establishment.”

13 **Section 2.** Subsections A, B, C and D of Rule 1 in Executive Order
14 61-14 are *repealed*.

15 **Section 3.** Title 17 G.A.R §4101(a), (b), (c) and (d) are *repealed*.

16 **Section 4.** Title 17 G.A.R., Division 1, Chapter 4 is hereby deemed
17 *amended* to conform to Part 541 of Subchapter A of Chapter V of Subtitle B
18 of Title 29 C.F.R., also cited as Title 29 C.F.R. §541, et seq.

19 **Section 5.** A new §3109.1 is *added* to Title 22 G.C.A. to read:

20 “§3109.1. **Publishing Applicable Laws.** The Director of
21 Labor shall post on the Department's internet website Title 22 G.C.A.
22 §3108 and Title 17 G.A.R., Division 1, Chapter 4, as *amended* herein.”
